Dear Lieutenant:

The March Delegate and General Membership meeting was held on Wednesday, March 29<sup>th</sup>, 2017, at the Villa Barone Manor in the Bronx. LBA President Lou Turco chaired the meeting and the following topics were discussed:

"LEADERS OF THE FINEST" AWARDS: Eight Active Duty Lieutenants and one Deputy Chief were honored and recognized by the members of the L.B.A. for their exemplary performance during highly creditable police accomplishments. Lou Turco, Chief of Patrol Terence Monahan, and Chief of Housing James Secreto presented the following Eight Lieutenants with the "Leaders of the Finest" Award: Lieutenant Jose L. **<u>REMINDER</u>**: At the meeting I quickly reminded the members that, as of July 1, 2015, they are entitled to the contractual benefit regarding the elimination of the home confinement regulations when out sick, mirroring the same agreements in place with the PBA, DEA and SBA. The pilot program provides that eligible employees, who request sick leave for an injury or illness, shall no longer be subject to home visitation and confinement, outside the hours of the employee's regularly schedule tour of duty, except where the convalescence for the injury or illness requires home confinement in the opinion of the Department's Medical Division, after conferral with the employee's personal physician.

At the meeting, I also informed the membership that almost every Lieutenant has agreed to voluntarily donate one (1) hour to the LBA's Catastrophic Leave Bank. As I have stated before, if each of our Lieutenants donate one (1) hour this would equate to an initial bank consisting of 1,706 hours or 195 days (based on an 8:45 tour). LBA Housing Director Larry

Hawkins has been appointed to represent the LBA on the panel to be established, in conjunction with the Department's Office of Labor Relations, in regard with considering who will be eligible to receive the additional time off. We are currently in final discussions with the City's/Department's Payroll Sections in regard with creating a mechanism to deduct the voluntary time from participating lieutenants vacation time to establish the Catastrophic Leave Bank. After the initial establishment of the Leave Bank, the LBA will not automatically request the donation of an hour every year, but will analyze the need for additional donations of time on an annual basis. In the immediate future, we anticipate a Department Operations Order to be published specifying the procedure of this program.

**LBA SCHOLARHSIP**: The LBA will once again offer scholarships to children of active and retired members. Awards will be based upon the student's SAT scores from any single day's testing; merging scores from different days will not be counted. Due to the inability to narrowly and reliably compare/convert ACT scores with SAT scores we will only consider SAT scores in awarding the scholarships.

To be eligible, students must be high school seniors, and send a copy of their SAT score to the LBA office (Attn: Gene Loewy) by Friday, June 30th, 2017. You MUST call the LBA Office soon after forwarding the SAT scores to confirm that we did in fact receive them. The following scholarships will be awarded:

- Two \$3,000 scholarships will be awarded. One each to the female and male student with the highest SAT scores
- Two \$2,500 scholarships will be awarded. One each to the second place female and the second place male student
- Two \$2,000 scholarships will be awarded. One each to the third place female and the third place male student

Winners will be notified prior to the July LBA Meeting, and awards will be presented at the July LBA Delegate and General Membership Meeting (date and location are yet to be determined). In case of ties, awards will be split among the highest scores achieved on any single day.
